I-20 Extension Request

Applying for an I-20 Extension

If you will not complete your academic program by the program end date on your I-20 form (item 5 on page 1 of the I-20), you must apply for an extension of your program of study at least **15 DAYS PRIOR TO** the program end date of your current I-20.

Failure to submit an extension application to the Center for International Services (CIS) before the end date of your current I-20 may result in violation of your F-1 Student status and loss of all associated benefits.

Procedures for requesting an I-20 extension

- 1. Complete Part I of the I-20 Extension Request Form
- 2. Request that Part II of the I-20 Extension Request Form be completed by your academic department
- 3. Submit the following documents to the CIS no later than 15 days prior to the program end date of your current I-20:
 - Application for (F-1) Extension of Program of Study, signed by your academic department
 - Photocopies of your passport identity and validity page(s), visa, I-94, and I-20 forms
 - Photocopies of your dependents' passport identity and validity page(s), visa, I-94, and I-20 forms
 - Proof of health insurance coverage
 - Proof of financial support (see Estimated Tuition and Living Expenses pages)

A CIS advisor will contact you if there are questions regarding your extension request and upon issuance of your new I-20 if the extension is processed.
