

### Minor as Visitor in Campus Housing

This permission form is required for any person between the ages of 16 – 17 years old to visit a Syracuse University residence hall or South Campus apartment. Parents or legal guardians of the minor visitor are the only individuals authorized to complete this form. Please note the following information:

- Visitors must be at least 16 years old. No person under age 16 is permitted to enter any University owned or operated residence hall or apartment without their parent or legal guardian present at all times. No person under age 16 is permitted to stay overnight in any University owned or operated residence hall or apartment.
- Visitors between the ages of 16 – 17 years old must be related to the student host. Any visitor may visit for no more than three (3) consecutive nights and no more than six (6) nights in a thirty (30) day period.
- This permission form must be submitted at least three (3) business days in advance of the minor’s visit. Minors aged 16 – 17 are not permitted to access University owned or operated residence hall or apartments without a Student Living Visitor Pass. Visitor passes are requested by the student host.
- When a 16 – 17 year old minor visits without their parent or legal guardian, the minor must be accompanied by their student host **at all times** while they are in campus housing or on campus property. Only one student may be designated as the minor’s host.

Minor visitors are subject to all University policies as well as local, state, and federal laws. Violations of policies by a minor visitor can result in parent notification, immediate removal from campus, loss of the host’s guest privileges, and or disciplinary action against the host.

Finally, I understand there are risks (both foreseeable and unforeseeable) associated with visiting or staying in the residence halls or apartments, including, without limitation, risks of bodily injury or death, or damage to or loss of personal property, and I hereby waive, release, and discharge the University and its trustees, officers, directors, employees, agents, contractors, and representatives (each, a "Released Party") from, any and all claims, causes of actions, demands and liabilities arising out of or related to my minor child's stay in the residence halls or apartments, including without limitation claims related to bodily injury or death, or damage to or loss of personal property, and liability for damages or the payment of any royalties, unless caused by the gross negligence or willful misconduct of a Released Party.
